

International Association of Anti-Corruption Authorities

Established in 2006, the <u>International Association of Anti-Corruption Authorities (IAACA)</u> is an independent and nonpolitical anti-corruption organization with the mandate to promote the effective implementation of the <u>United Nations</u> <u>Convention against Corruption (UNCAC)</u> and assist anti-corruption agencies (ACAs) worldwide in the prevention of and fight against corruption. Up to now, 186 ACAs from different countries and regions have joined IAACA as members. Members are categorized under five regional groups with reference to the <u>United Nations Regional Groups of Member</u> <u>States</u>. Regional Coordinators are appointed to deepen communication and collaboration with ACAs within their regions, and arrange tailor-made training activities for them.

President and Secretariat

Mr Danny Y M Woo, Commissioner of <u>the Independent Commission Against</u> Corruption (ICAC), the Hong Kong Special Administrative Region of the <u>People's Republic of China</u> is the current President, and ICAC serves as IAACA Secretariat. Mr Chin Kit CHEUNG, Assistant Director of International Cooperation of the ICAC is the Secretary-General of the Association.
